COMMUNICATIONS, PRESENTATIONS & PUBLIC COMMENT

Minutes: July 26, 2017 – Boreth made the motion to approve the minutes as revised that noted the vote on the enterpirse zone renewal at the last meeting. Swigart seconded. Motion carried 6-0.

Library Minutes – Informational Only

Representative Rick Lewis for House District 18 informed Council of several House Bills that were passed at the last session. He announced that Molalla will be receiving an additional \$750,000 for the Highway 211 improvements and \$230,000 per year for the next 8-10 years from the implemented fuel tax for local infrastructure and maintenance. There is also opportunity for grant funding through the Safe Routes to School Program and grant funding for bike and pedestrian improvements. Boreth and Thompson thanked Lewis for attending the meeting and providing the community with the information. The both stated that they appreciate his efforts and support for Molalla in his position because that was not really received from his past predecesors.

Frank Walker of Frank Walker and Associates from Salem, Oregon spoke on behalf of his client submittal for an urban growth boundry expansion. He urged the Council to encourage and support city staff in their efforts to review and consider the application. Huff stated that an application has been received but the city is not considering a UGB expansion at this time or in the near future based on other critieria the city has to meet in order to do so.

NEW BUSINESS

Letter of Support for Graves Church

Thompson stated he was approached by Graves Church in Molalla for a letter of support for a grant opportunity for them to replace the roof on that facility. The church is and has been used for emergency preparedness activities if a disaster should happen. There was no opposition from then Council regarding the request so Thompson will draft the letter and provide it to them.

Utilities Rate Study Discussion and Presentation

Steve Donovan of Donovan Enterprises, Inc gave a presentation that covered the information in the Utilities Rate Study included in the agenda. Discussion between staff and Council took place in regard to the rates being proposed and what each one can do and affect the community as a whole. ORDINANCE No. 2017-___

AN ORDINANCE AMENDING SECTION 1.02.240 OF THE MOLALLA MUNICIPAL CODE RELATED TO THE AUTHORIZATION OF EXPENDITURES.

WHEREAS, Section 1.02.240 of the Molalla Municipal Code regulates approval authority for certain city expenditures; and

WHEREAS, the City desires to amend such approval authority to increase efficiencies.

NOW, THEREFORE, THE CITY OF MOLALLA ORDAINS AS FOLLOWS:

<u>Section 1:</u> Section 1.02.240 of the Molalla Municipal Code is hereby amended as follows (additions in <u>underline</u> and deletions in <u>strikethrough</u> fonts):

1.02.240 Authorization of expenditures.

- A. Subject to Sections 21.D. and 22.C.3. of the City Charter, a A department director or manager shall not spend or commit more than \$45,000.00 of budgeted funds without approval of the City Manager.
- B. Subject to Section 34.d.1. of the City of Molalla Charter, the City Manager shall receive Council approval prior to spending or committing to making any budgeted expenditures in excess of \$100,000.00 that are outside the scope of regular daily city operations.
- C. The City Manager shall receive Council approval prior to making any expenditures, regardless of the dollar amount, if the contemplated expenditure in not included in the adopted budget for the given fiscal year in which the contemplated expenditure is to be made.

Section 2: This Ordinance shall take effect 30 days after enactment.

ORDINANCE 2017-07

AN ORDINANCE VACATING A PORTION OF A PUBLIC RIGHT OF WAY LOCATED WITHIN THE CITY LIMITS AND BEING A PORTION OF SHIRLEY STREET IN THE CITY OF MOLALLA, OREGON IN THE COUNTY OF CLACKAMAS

WHEREAS, the Molalla City Council, on August 9, 2017, initiated a street vacation by action of resolution 2017-11 of the City Council pursuant to Oregon Revised Statutes 271.130, to vacate a portion of a public right of way located with the city limits and being a portion Shirley Street as described as commencing at the point of intersection of the centerline of Cole street with the easterly extended southerly right-of-way line of Shirley Street in J.V.Harless addition to Molalla as shown on Exhibit A attached to this Ordinance; and

WHEREAS, the City published notice of a public hearing on the proposed street vacation in the Molalla Pioneer on August 9, 2017, August 16, 2017 and August 23, 2017. City staff posted 3 copies of the notice with all required information at the site of the proposed vacation areas and gave note by mail to property owners as required by law; and

WHEREAS, the City Council held a public hearing on the proposed vacation on August 23, 2017, at which time the public was invited to appear and give testimony on the proposed street vacations; and,

WHEREAS, the City has received the written consent from all abutting property owners or the consent of more than 2/3 of the affected area as defined by Oregon Revised Statutes, per ORS 271; and

WHEREAS, the public interest will not be prejudiced by the street vacation because the portions of Shirley Street and Cole Street to be vacated are not currently used for access to any adjacent property, are not required to meet City street standards, and are located on area needed by the City of Molalla to construct improvements for the benefit of the public.

THE CITY OF MOLALLA ORDAINS AS FOLLOWS:

SECTION 1. Those portions of Shirley Street and Cole Street in the City of Molalla, Molalla County, Oregon, described in metes and bounds on Exhibit "A" attached hereto is hereby declared to be vacated, for the length of the vacated right of way, except for the public retention of a perpetual public utility easement for the use, maintenance, repair and replacement of any existing public utility now located under or above the vacated street area, if any.

SECTION 2. Title to the vacated portions of Shirley Street and Cole Street shall devolve to the property owner whose lands border the vacated area pursuant to ORS 271.140.

SECTION 3. A certified copy of this Ordinance shall be filed with the Clerk of Clackamas County in accordance with ORS 271.150.


