CONTINUED BUSINESS

Findings, Facts and Decision of Shirley Bank Sub-Division Appeal

Council reviewed the Findings of Fact and Decision with Huff. Per Council at the public hearing a prior meeting, the document has revised as voted. Huff referenced page 4, conditions 7 and 13. A 2.

Council discussed amending the noted sections for more clarity. Boreth made a motion to amend Condition 7, seconded sentence to "Applicant shall provide a temporary removable wall allowing for the future pathway." Palumbo seconded. Motion carried 7-0.

Fisher confirmed with Council that the temporary wall will match the existing wall.

Boreth made a motion to approve the ODOT Appeal for P45-2016 as amended. Dragowsky seconded. Motion carried 7-0.

NEW BUSINESS

Library Board Appointment

Klein made a motion to appoint Mary Gilson, Valerie Coy and Paula Beck to the Library Board. Childress seconded. Motion carried 7-0.

Authorize a Change in Capital Improvement Expenditures

Fisher addressed Council. The tanker truck that we have has failed and a new one is needed. Staff looked at repairing the leaking tank but were advised it's only a temporary fix based on the bad condition of the truck. Bids were furnished to Council for consideration from the state procurement program. \$129,048 and additional warranty and service plans for \$2,600 and \$600. The current tanker truck will go to surplus and those funds will go back into the water, sewer and street funds that were affected by authorized change.

Fisher is asking Council to move what we would have put into budget next year for the tanker truck back into the Capital Improvement Expenditure in the next fiscal cycle since the project that was going to be considered under this general ledger line item has been put on hold. This will allow us to make the purchase this year instead of next. Childress made the motion to authorize the proposed change. Boreth seconded. Motion carried 6-0-1. Swigart recused due to conflict of interest.

Swigart recused himself from the vote because a family member works for company we would be purchasing the truck from.

ODOT Joint Letter with City of Molalla and Molalla River School Dist.

Thompson stated that discussion have taken place between the parties and would they would like city staff to draft a joint letter to ODOT for a crosswalk improvement on HWY 211 from Stone Place

Apartments to the other side of HWY 211 for public safety. Dragowsky made the motion to instruct staff to draft the letter to ODOT. Boreth seconded. Motion carried 7-0.

STUDENT LIASION

Thompson will be reaching out to the Principal of the High School for possible candiates for this position. The city has a formal process in place that has be reviewed by legal. Thompson hopes to have applicants in the next 2 months.

RESOLUTIONS

Resolution 2017-04: Recreational Immunity Resolution

Huff stated that current house bills before the legislature are trying to bring back recreactional immunity. The Leagues of Oregon Cities has drafted the resolution in the packet and has asked all Oregon cities to approve in support of the bill giving recreational immunity back to municipalites. Palumbo made the motion to approve resolution 2017-04. Childress seconded. Motion carried 7-0.

Background:

Staff requested quotes from three contractors (Knife River, Canby Excavating, and GT Excavating) under an intermediate procurement to make pavement repairs throughout the City. One bid was received and deemed responsive from Knife River in the amount of \$85,888.01. The project budget is \$70,000 and staff worked with the contractor to reduce quantities to remain within budget. Staff recommends awarding the contract to Knife River in the not-to-exceed amount of \$70,000 and authorize the City Manager to execute the contract and any necessary change orders within the existing budget.

Background:

Staff requested quotes from three contractors (GT Excavating LLC, Cascade Water Works Inc, and Schneider Water Services) under an intermediate procurement to replace the existing effluent manifold prior to mid-June in advance of our peak water demand. One bid was received and deemed responsive from GT Excavating LLC in the amount of \$15,980. Staff recommends awarding the contract to GT Excavating LLC and authorize the City Manager to execute the contract and any necessary change orders within the existing budget.

RE: WTP Filter 3 & 4 Manifold Replacement

Hi Dan,

The following images are of the effluent manifold on filter #3 and #4. This manifold is severely





corroded and is in need of repair before it begins to leak. We have investigated several

alternatives and determined that the existing material is too thin to perform repair weld and due to the configuration and condition of the manifold we will also not be able to install a temporary repair band. Our only option at this time is to replace this section of the system in advance of our peak water demand this summer and this effluent pipe is critical to the operation of filter #3 and #4. Filtered water is pumped via two centrifugal pumps and past two wafer check valves. Over the years the steel pipe has corroded at the chlorine point of injection. If the manifold develops a leak, staff will be forced to take these filters offline and we will not have the capacity to meet the summer water demands. We are required to inject sodium hypochlorite for disinfection and Soda Ash for corrosion control. These two chemicals get injected into the manifold before the water travels into the finished water reservoirs. The new pipe will be built of stainless steel and we will add two injection quills that will inject the Sodium Hypochlorite and Soda Ash into the center of the pipe instead of the edge of the pipe. This will keep this problem from happening again. Included with this memorandum is a summary of the intermediate procurement results for replacement of the manifold.

The new pipe will be made of stainless steel and injection quills be installed to prevent this from happening in the future. We have requested (3) bids for the repairs.
