 Two projects are currently on going which includes Visioning and Banner Projects.
 - Council training should be tracked better. This would allow the community

For this reason, the City has terminated the contract. PWD Fisher wants to execute a contract with the engineering firm currently acting as a subcontractor to the project. Fisher assures Council that there is nothing changing in the contract proposal

and there will not be any additional costs involved. Mayor Thompson has concerns because there is no contract for Council to review. Councilor Boreth is confident in PWD Fisher ability to execute such a contract successfully. After a brief discussion it is determined that the sub-contractor will only finish the projects that are ongoing they will not start any new ones.

Motion is made by Councilor Swigart to allow PWD Fisher execute the contract with the sub-contractor to become the new main contractor for engineering services Councilor Boreth seconds. Motion carries 6-ayes Mayor Thompson is against.

PWD Fisher explains the situation regarding the slide on Highway 213 in Mulino Fisher wants to promote the route changes on our website in order to help commuters in our area.
