### 6. **NEW BUSINESS**

- A. Discussion and/or Action Regarding Biosolids Dewatering & Hauling Award.

  PWD Fisher presented the following information; the bids were reviewed and River City

  Environmental was deemed the lowest responsible bidder. A notice of intent to Award was issued to all bidders on May 31, 2018 and no protests were received.
  - Not-to-exceed \$335,000 for FY 2018/2019
  - 5 year span not-to-exceed amount of \$2,729,877

MOTION by Councilor Boreth: To approve City Manager Huff to sign agreement with River City Environmental. Second by Councilor Swigart. Motion carries all ayes (5-0).

B. Discussion and/or Action Regarding SRO Contract Agreement, Chief Lucich presented Council with an Intergovernmental Agreement between the City of Molalla and the Molalla River School District that has already been vetted by the City Attorney. The District has committed to \$50,000 towards the new SRO position. Council briefly discussed the necessity of the SRO especially now in this culture.



MOTION by Councilor Palumbo: To approve CM Huff to execute the IGA. Second by Councilor Boreth. Motion carries all ayes (5-0).
