### A RESOLUTION ADOPTING THE MOLALLA URBAN RENEWAL AGENCY BUDGET FOR THE FISCAL YEAR 2019/2020; MAKING APPROPRIATIONS; AND CATEGORIZING AND **LEVYING TAXES**

The board of the Molalla Urban Renewal Agency on the 12th day of June, 2019 sat in regular session for the transaction of agency business.

WHEREAS, the Molalla Urban Renewal Agency Budget Committee has reviewed and acted on the proposed Agency budget; and

WHEREAS, the Molalla Urban Renewal Agency Budget Committee approved and recommended a balanced budget to the Urban Renewal Agency Board on May 2, 2019; and

WHEREAS, in accordance with State law, the Urban Renewal Agency Board has held a public hearing on

the budget as approved and recommended by the Molalla Budget Committee.

NOW, THEREFORE, THE MOLALLA URBAN RENEWAL AGENCY RESOLVES and hereby adopts the FY 2019/2020 Budget approved by the Budget Committee on May 2, 2019, in the amount of \$1,441,500.00, of which \$332,000.00 is in reserves.
