- PC Botsford Introduces the continuation of the Public Hearing for Appeal on Administrative Decision Application P62-2017.

 - Reviews the economic development history in Molalla and what groups Mitch has been a part of. Mitch gives his prospective on why it is unnecessary for Jim Taylor to be required to sign the Waiver of Remonstrance.
 - Community Planner Aldo Rodriguez summarizes the last meeting on 1.3.18.
 - Public Works Director Gerald Fisher addresses memo (Exhibit A).
